Dear Camper:

Welcome to the 2024 Celebration of America Event. Please note, that if camping rules are not followed you may be asked to leave at any time by Oxford Plains Speedway Management and may not be allowed to camp in the future at the track. Due to the Overwhelming interest, please read the following rules carefully as some items have changed from years past.

**ALL CAMPERS MUST ENTER THE PROPERTY ON THE TURN 1 SIDE OF THE FACILITY ONLY AND PROCEED DIRECTLY TO CAMPER CHECK IN CLARLY MARKED BY THE SIGNS. ALL CAMPERS MUST CHECK IN BEFORE CHOOSING THEIR SPOT(S).**

**BECAUSE OF THE LARGE INTERERST IN CAMPING FOR THIS YEARS EVENT, CAMPING SPOTS WILL BE ON A FCFS BASIS AND THERE WILL BE NO ADVANCED RESERVATIONS.**

**THERE WILL ALSO BE NO SAVING OR ROPING OFF SPOTS FOR LATER ARRIVAL. IF YOU WISH TO CAMP WITH SOMEONE, YOU MUST ARRIVE WITH THEM TO GUARANTEE PLACEMENT.**

**ALL PERSONAL VEHICLES MUST BE CONTAINED WITHIN YOUR MARKED CAMPING AREA, OR PARKED IN THE REGULAR PARKING LOT IN AN APPROPRATE SPOT. NO PARKING IN THE ROADWAY. THIS WILL BE PATROLED BY SECURITY.**

Campers/Tents will be allowed onsite beginning Saturday, June 29, 2024 at 9 am. Campers must be removed by Monday July 8, 2024 at 12:00 pm (noon). **All campers/tents must be registered** with Oxford Plains Speedway and must display the Oxford Plains Speedway Camping Permit (issued at registration) at all times. Any camper/tent that is not registered or fails to display their camping pass is subject to removal by Oxford Plains Speedway Management.

Camping costs are as follows:

**Flat Fee for Camping: \$125**

**\*\*\* Oversized CAMPER's (longer than 36 feet) may be required to purchase an additional lot.**

**Check in times will be 9am to 6pm only Saturday through Wednesday only. Camper Registration will close by 4pm Tuesday July 2nd OR before that time if we are sold out. There are a limited number of spaces available.**

**Payment in CASH ONLY- Exact Change is preferable**

Below is the list of rules that must be complied with at all times during Oxford 250 week.

- Only self-contained units permitted. Tents are allowed. Hook-ups and service facilities are not available.
- All campers/tents must be parked and set up neatly and must comply with Oxford Plains Speedway Management's decisions on where and how the camper is parked. Maintenance of the area around the camper/tent is the responsibility of the owner. The camp site must be free of any and all debris such as trash, toys, and other objects that clutter the area, including any pet waste. Carry-in, carry-out and tidy up camping area before departing. **Sites left in excessive disarray may be subject to a fine.**
- A decision on campfires will be made by the town of Oxford. If allowed, no excessive bon fires. Absolutely NO out of state fire wood is allowed per Maine state law. Campfires must use a metal ring with bottom.
- Personal vehicles will be parked within your designated camping area OR in regular parking lot.
- ABSOLUTELY NO FIREWORKS.
- All campers (adults & kids) must wear footwear at all times.
- Anyone who is fighting or doing anything that is deemed disruptive by Oxford Plains Speedway Management will lose all camping privileges and may also be suspended from the property.

The owner of the camper/tent must sign camping agreement and provide contact information to Oxford Plains Speedway.
